1. Interpretation

- "Account Currency" means the currency in which the Account is denominated.

 "Card" means a Standard Chartered Visa International Debit Card issued by the Bank at the request and in the name of the person narred upon it for use in connection with debit card facilities provided by the Bank, including any renewal or replacement Card.
 "Cardholder" means the person having power alone to operate the Account in accordance with the bank mandate in respect thereof.

 The Terms form the contract between the Cardholder and the Bank. The Cardholder shall be deemed to have unconditionally agreed to and accepted the Terms by signing the Card application form, or acknowledging receipt of the Card in writing, or by signing on the reverse of the Card, or by performing a transaction with the Card or by requesting activation of the Card to the Bank's Call Centre or after 10 days have elapsed since the Card was dispatched to his address on record. The Bank may communicate the amended Terms in any manner as decided by the Bank.

 These terms and conditions and the banking practices and charges relating thereto may be changed by the Bank at any time by notice these for the Cardholder. Any such changes will be effective from the date of the notice or such later date as may be specified therein.

Governing Law and Jurisdiction

These Terms and Conditions shall be governed by and construed in accordance with the law of Zimbabwe and the Cardholder irrevocably agrees to submit to the exclusive jurisdiction of the courts of Zimbabwe in connection herewith.
